## A PRESENTATION ON THE DTI ONE STOP SHOP & DUBE TRADEPORT

As mentioned in the July newsletter our next event is a breakfast presentation from the DTI on the **One Stop Shop** and the **Dube TradePort** on Friday the 22<sup>nd</sup> of September at the **GGDA Office** at The Place No 1 Sandton Drive (the same building where the recent Macquarie event was held). As a reminder, opportunities in 18 business sectors are supported by the DTI, while financing, training allowances and support to attend international trade shows are offered through this mechanism. The Dube TradePort is a **Special Economic Zone** centered around the King Shaka airport near Durban. Being a SEZ, it confers a

number of **benefits and assistance packages** to business participants including various **tax and related incentives**. Both local and international investment is being targeted for the zone that is being developed to stimulate economic growth and it supports a number of industry sectors aimed at local and international trade. Apart from the international airport, **Richards Bay Harbour** is 90 minutes from the TradePort, which will facilitate further trade. There is a 50 year master plan to create an international Aerotropolis at

the zone and this is an exciting venture well worth hearing more about. ## AUSTRALIAN GOVERNMENT AFRICA TRADE ENQUIRY

A meeting was held on Friday the 4th of August at **Macquarie Bank** and various members and other interested parties gave their input on trade related issues. H.E. Adam McCarthy, High Commissioner to South Africa and Gita Kamath, Assistant Secretary Africa Branch, Department of Foreign Affairs and Trade Canberra spoke in terms of setting the scene and emphasized the value of business input for the Australian Government to consider on this issue. The most prominent issues raised from the floor were concerning;

- **Visa applications** for business travelers, which were generally described as being onerous.
- Policy uncertainty from the South African Government.
- Making use of more **networking and trade promotion** efforts between Australia and Africa.
- Australia should make more use of other **industry sectors outside of mining** to create business opportunities in Africa.

## COUNTRY OF ORIGIN FOOD LABELS IN AUSTRALIA

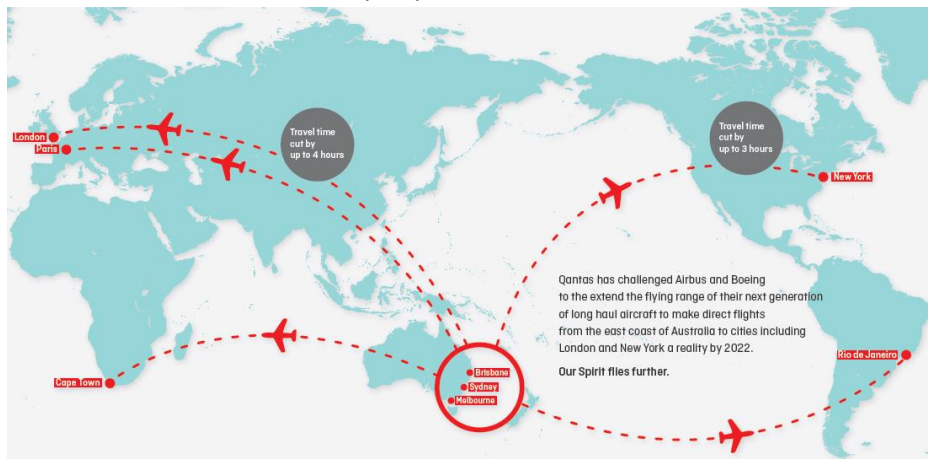


For Southern African companies looking to **sell food products into Australia**, new Country of Origin Labelling (CoOL) will be mandatory from **1 July 2018**. The Australian Government has published information which will identify businesses that need to comply with the new standards, discuss priority and non-priority foods (most drinks and chocolate as examples), explain how to calculate percentage by weight of Australian ingredients in food and other relevant information. Guides on how to **design the various labels** with the required label content and pro-forma labels are available to be downloaded. These guidelines apply to foods packaged in Australia but containing foreign ingredients and food packaged outside of Australia. **Find out more** to go to the Government website for more information. ## A NEW DIMENSION TO LONG HAUL ROUTES



QANTAS started their first long-haul flight to **London in 1947** and it took four days with all the stopovers. The company CEO Alan Joyce, with what is called Project Sunrise is now challenging the aircraft manufacturers **Airbus and Boeing** to make non-stop flights to London from Australia a reality by 2022. Most people prefer the nonstop flights, especially business travelers. So QANTAS is aiming on a **direct 20 hour – 20 minute flight to London and 18 hours to New York** both from Sydney. This will decrease existing flying times for the two routes by four and three hours respectively. Currently the longest nonstop flight to the US from Australia is the Sydney-Dallas route at around 16 hours. Earlier this year, QANTAS said it would commence nonstop flights to **London from Perth** in March 2018, using a Boeing 787-9. So competition on the long-haul routes is hotting up with Singapore Airlines planning new direct flights to the US next year and United Airlines already flying out of Singapore direct to San Francisco. And with the expected competition from the aircraft manufactures, it will be interesting to see which aircraft can reach the Sydney-London route first.
